| <b>VOCA</b><br><a href="#">Report FAQ</a>                          | Some data is reported for only new clients in reporting period (ex. demographics), while other data (ex. victimization, services) are reported for all clients served. | Yes- report all presenting victimizations that a victim received services for in the reporting period. | Presenting victimization is the victimization for which they received the service. If they received services for multiple victimizations in that quarter, report those. <i>Programs are only required to report victimizations they provide services for.</i> | Does not differentiate   | Yes- report secondary victims in the same categories that primary victims are recorded.                |
| <b>VAWA</b><br><a href="#">Examples and reporting instructions</a> | Report all victims who were partially served, not served, fully served (all victims in the reporting period. Another question asks for new victims’ victimization only | No- choose only a primary victimization for question 29.   | The victimization for which the person first requested services.  | Yes- report if an additional victimization is present, categorized by their primary victimization, in question 31                            | Yes, reported separately in question 32—Only report secondaries that received services.                |
| <b>SASP Federal</b><br><a href="#">Instructions</a>                | Report total served/partially served/not served.   | Only primary victims during the reporting period.  | A victim is defined as one against whom the sexual assault was directed.  | No   | Yes, reported separately—Only report secondaries that received services.                               |
| <b>SAPCS State</b>   | Report new victims and current victims   | No   | unsure  | No   | Yes- include both primary and secondary victims.   |

| <b>OAG</b>  | Anyone served  | Report for both primary and secondary all information.  |
| <b>VOCA</b><br><i>source:</i><br><a href="http://vocapedia.com">vocapedia</a> . | The VOCA definition of “crime victim” or “victims of crime” covers both primary and secondary victims; see 20107(e). Your program needs to classify the specifics of these terms for subrecipients. In addition, however the SAA classifies these terms, PMT reporting will include the total number of all individuals who receive services funded by VOCA plus match funds | Report for both primary and secondary all information.  |
| <b>VAWA</b>   | Separated by victimization.  | Only report services provided to the primary client. Report shelter nights for primary client and family members. |
| <b>SASP Federal</b>   | Report total served/partially served/not served.   | Only report services provided to the primary client   |
| <b>SAPCS State</b>  | Report new victims and current victims   | Report for both primary and secondary all information   |
| <b>HUD</b>  | “head of household”  | N/A   |
